Clerk's Report -

 Preparing for the year end with annual reports coming due in January. To prepare the Supervisors, the January meeting will consist of reviewing the Administrative Policy and annual designations.

OPEN FORUM (FKA PUBLIC INPUT) -

• Citizen Tom Larson provided some general information about FEMA and HUD and how they continue to struggle with all the claims from the disasters throughout the country, and now with fires in California.

OLD BUSINESS

SUPERVISOR REPORT

Supervisor Peterson –

Working with Fire Departments to receive the itemized invoices for 2025.

Supervisor Wold -

- Continue to work with FEMA on reimbursements for 3 mitigation requests. I got a call from our project manager, and he said, if you want to speed up your chance of getting any money, you should update these requests for mitigation because they were a little tenuous to fit the parameters at best. I agreed they were, but it's worth taking a shot at it. And so, to keep a regular claim, which is \$10,000, they re-prepared everything without mitigation. It may be another 6 months before we get approval or any reimbursement.
- Before we do road inspection this year, I think it would be worthwhile to get an affordable dash cam. You know, they're ~\$200-\$300, and then every year when we do our road inspection, we can just record the condition of the roads, because that's something we run into with FEMA claims, if we don't have proof that the road wasn't damaged, maintained prior to the storm event, they can deny our claim. So that, since we're driving every road anyway, spend \$250 on a dash cam, and then we have photographic evidence there was no washout as of that spring. We can talk about that at the budget meeting in February. Supervisor Peterson stated he may have an older one that can be used. Will look for it and provide an update next meeting.
